

BAA Advocacy Priorities

- Committee on Legislation and Policy: Farm Bill Must Haves
 - 2023 Farm Bill Research Title VII Recommendations Long-form document
 - Recommend consideration of an overall funding request of \$8 billion for Farm Bill Title VII over the five-year life of the authorizing legislation. Agricultural and natural resource research, Extension, and facilities would be core themes of any related advocacy. Mandatory Funding Request - Research Facilities Act
 - Of the \$8 billion in mandatory funding, we would advocate for \$5 billion in mandatory funding for the Research Facilities Act in Title VII.
 - While there are many variables at play, including if Congress will allow significant increases to mandatory funding, the Farm Bill represents the best near-term opportunity of injecting substantial funding into the RFA and address one of the most compelling needs for our system.
- Education Grants Programs for Hispanic-Serving Institutions
 - This competitive grant program expands and strengthens academic programs in the agricultural sciences, natural resources, forestry, veterinary medicine, home economics allied, and disciplines closely to the food and agriculture production and delivery systems at Hispanic-serving colleges and universities, including two-year community colleges that have at least 25 percent Hispanic enrollment. The Farm Bill authorizes the program at \$40 million per fiscal year, and historically it has received appropriations of \$11-14 million each fiscal year.

BAC Advocacy Guiding Principles

- Focus on widely-beneficial programs (appropriations lines)
- Maintain year-to-year consistency
- Don't undercut President's Budget Request
- Focus on the core.
 - 79% and 89%
 - Nothing else possible minus the core!
- Emphasis on equity
- Be realistic!
